


- Fire ring has an overall diameter of 32 1/8" x 9" high and is constructed of 3/16" thick steel (A1011).
- Fire ring is constructed with a formed (not welded) double flange for superior strength.
- Grate is constructed from 1/2" dia. A36 steel bars located on 1 1/8" centers. The non-adjustable theft proof grate has a cooking area of 270 sq. inches.
- Grate handle is constructed of a 5/8" dia.
 A36 steel bar with stay cool spring grips suitable for public use.
- Ring is mounted using staples that allow the ring to tilt back for ease of cleaning or optional spade anchors.
 The spade anchors permanently anchor the fire ring to the ground.
- All joints are continuously welded.
- All exposed corners are chamfered for safety.
- Standard finish is a non-toxic black powder coat.
- Approximate weight = 72 lbs.
